ORDER:

In the proceedings first cited, a temporary list of Assistants fit for appointment as Assistant Commercial Tax Officers by recruitment by transfer of service for the year 2006 for the State Unit has been drawn and communicated.

2. The vacancies in the category of ACTO for recruitment by transfer of service for the year 2007 has been estimated at 103. Another 12 vacancies meant for scheduled castes and 2 vacancies meant for scheduled tribes that have remained unfilled from the ACTO State list for the year 2006 are also carried forward as backlog vacancies in terms of General Rule 22. Based on proposals received from all Joint Commissioners/Deputy Commissioners (CT) including Enforcement and in terms of Special Rule 3 for the TN CT Subordinate Services, a temporary list of Assistants fit for appointment as Assistant Commercial Tax Officers by recruitment by transfer of service for the year 2007 for the State Unit is hereby drawn and communicated.

3. The list, as in annexure, is purely temporary and is subject to the outcome of the Special Leave Petition in SLP in CC No.1762 of 2006 filed by the Government of Tamil Nadu before the Honourable Supreme Court of India with regard to the issue of following rule of reservation in recruitment by transfer of service.

4. All the Joint Commissioners (CT), including Enforcement, are instructed to communicate this order to the individuals concerned and also to their seniors in the respective Divisions, whose names have not been included in the annexed list.

5. The Joint Commissioners (CT) are instructed to withhold the communication of this order to those individuals against whom disciplinary proceedings under Rule 17 (b) of the Tamil Nadu Civil Services (Discipline and Appeal) Rules have been initiated by service of charge memos or charge sheets have been filed in any criminal cases initiated against them or cases are pending before the Tribunal for Disciplinary Proceedings or punishments have been imposed subsequent to the recommendation of their names in the nomination rolls by the respective Joint Commissioners (CT).

6. Objections, if any, against non-inclusion of any individual in this panel may also be addressed by the individuals through the respective Joint Commissioners to the Principal Secretary/Commissioner of Commercial Taxes within thirty days of receipt of this order.
