ORDER:

In the proceedings first cited, the State List of Assistant Commercial Tax Officers for the year 2000 was drawn and communicated. In the proceedings second to eleventh cited, certain orders of inclusion have been issued in respect of the 2000 ACTO panel.

2. The Hon'ble Tamil Nadu Administrative Tribunal as well as the Hon'ble High Court of Madras have held that the rule of reservation has to be followed in promotions only for SC and ST categories. The SLP (Civil) in CC No.1762 / 2006 filed by the Government of Tamil Nadu on this issue is now pending before the Hon'ble Supreme Court of India.

3. Therefore, in view of the rule of reservation in promotion for categories other than SC and ST being sub-judice, subject to outcome of the said SLP pending before the Hon'ble Supreme Court of India, the individuals belonging to the SC/ST category, who have been included in the said list vide either in order of their original seniority in the Assistant cadre or on orders of the Hon'ble High Court, Madras are placed at the appropriate positions. The individuals of other categories, who have been included in the said list vide proceedings first to eleventh cited are placed below the SC/ST candidates temporarily subject to outcome of the said SLP. The revised list is given in Annexure to this order.

4. The list now drawn is purely provisional and is subject to revision depending upon the outcome of the SLP (Civil) in CC No.1762/2006 pending before the Hon'ble Supreme Court of India.
