**Exemption in respect of Luxury tax payable by Thiruvallur Tamizhagam Guest House, Uthagamandalam under Tamil Nadu Tax on Luxuries Act.**

No.II(2)/CTR/561/2008.—In exercise of the powers conferred by sub-section 91) of Section 23-a of the Tamil Nadu Tax on Luxuries Act, 1981 (Tamil Nadu Act 6 of 1981), the Governor of Tamil Nadu, hereby makes an exemption on and from the 1<sup>st</sup> April 2003 in respect of the Luxury tax payable under the said Act by Thiruvallur Tamizhagam Guest House, Uthagamandalam.
